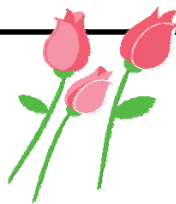

**STATE PRESIDENT'S MESSAGE** *By: Sam King*

The League of Woman Voters celebrated our 90<sup>th</sup> birthday in February. We then roared into March with a busy advocacy agenda fighting for good governance with an informed understanding of the innovation that comes with each new decade. The League of Women Voters respects the process of democratic government dependent upon informed, active, citizen participation. League at every level - national, state and local - works to ensure that our elected officials and governmental bodies protect the citizens' right to know, and gives adequate notice of proposed actions in a clear and transparent form. Our democratic-representative government is charged with creating policy ensuring that every person has access to public education, minimally ensuring national literacy while maximizing transition into secondary, post-secondary and lifelong learning so that individuals have equal opportunity and do not suffer legal, economic, or administrative discrimination. A literate population is inherent to supporting a sustainable quality of life for our citizens so that, as a nation, we are globally competitive and a leader at the international table.

The League of Woman Voters supports responsible government. Responsible government must be responsive to the will of the people; maintains an equitable and flexible fiscal system, promotes conservation and the development of resources in the public interest, provides solutions for economic and social problems that affect the general welfare, promotes a sound economy and adopts policies that facilitate solutions to domestic and global issues. League positions begin with our mission and develop as the result of study and consensus requiring respect for individual differences, collaboration and cooperation. Cooperation and collaboration are basic for sustainable, reasonable solutions and policy. The League of Women Voters of Nevada is a visible advocate. Our vision, beliefs and intentions guide activities and advocacy. We lobbied during the 26<sup>th</sup> Special Session of our Nevada Legislature; participated in the annual meeting of the Nevada Taxpayers Association, partnered with the Las Vegas Clean Cities Coalition, participated in the Washington D.C. Oxfam International Summit and Lobby Event with Sisters of the Planet, focusing on global climate change, economic impacts, health care, and woman's issues in celebration of March 8, 2010 International Women's Day. In cooperation with the League of Woman Voters US, our Nevada League promotes an independent judiciary and will be providing forums to explain upcoming Nevada ballot questions for adaptation of the merit selection of judges and asking voters to support the creation of a Nevada appellate court.

The United States Constitution requires that a census be taken every ten years. The 2010 Census count will determine a return of federal dollars to support state services. We are partnering with the Nevada 2010 Community March to Mail Boxes Census in preparation of count day.

**EDUCATION:** The League supports adequate and equitable funding for all levels of public education, is committed to continuing efforts to establish excellence in all our children’s schools.

**ENVIRONMENT:** We are interested in learning more about various aspects of our environment, the political processes that govern decisions about the environment, and sharing ideas and stories about those issues.

**HEALTH:** We continue to work in coalition with other groups to support health issues relevant to our local as well as national populations. Members interested in learning how to affect a change in the health care system are encouraged to join us.

**JUVENILE JUSTICE:** An ongoing committee that often meets and works in conjunction with the Education Committee to bring awareness to the problems facing incarcerated juveniles.

**CRIMINAL JUSTICE:** A dormant committee that needs someone to chair and lead this much needed committee. Volunteers??

**LEGISLATIVE:** A popular and very active group that directs the legislative program for our League.

**AFFORDABLE HOUSING:** We continue to monitor and work with the community on finding solutions to a growing problem in our community. .

**MEMBERSHIP:** An organization is only as strong as its membership. We actively go into the community and recruit new members as well as increase the community’s awareness of the activities of our League to show how being involved with League is educational and fun.

**VOTER SERVICES:** We are an organization that endorses and assists in voter registration. Classes are held regularly through the County Registrar to provide members with training to become voter registrars.

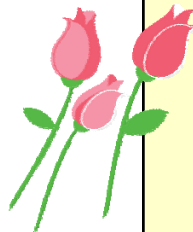
